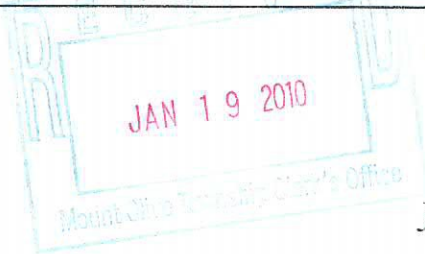


E. Injury:
