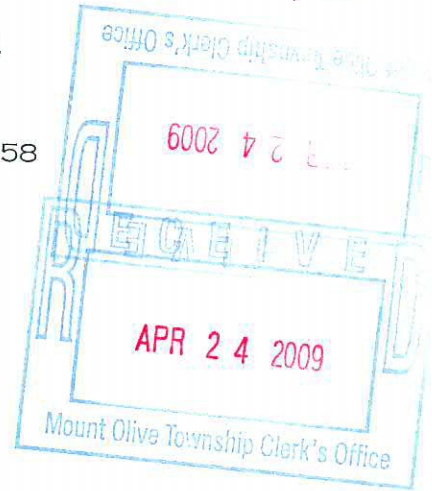

AN ORDINANCE TO AMEND CHAPTER 100 OF THE CODE OF THE BOROUGH OF STANHOPE BY REVISING ESCROW FEES FOR CERTAIN "C" VARIANCES

BE IT ORDAINED by the Mayor and Council of the Borough of Stanhope, Sussex County, New Jersey as follows:

Section 1. Section 100-34.3 of the Code of the Borough of Stanhope is hereby amended as follows:

<u>Type</u>	<u>Application Fee</u>	<u>PLUS Escrow Account</u>
"C" Variance: residential, other than lot size	\$75.00	\$500.00
"C" Variance: non-residential	\$75.00	\$500.00

Section 2. All other provisions of Ordinance Section 100-34.3 not amended by this Ordinance shall remain in full force and effect.

Section 3. When effective, this Ordinance shall take effect upon passage and publication as required by law.
