
Dear Mr. Kron:

This is in response to your letter of April 8, 2009 regarding the subject project. With your letter, you enclosed a copy of the Department of Environmental Protection's (Department) January 22, 2009 determination that was based on its review of the Highlands Applicability and Water Quality Management Plan application. That review determined the proposed project to be *Not-Exempt/Consistent*. Also enclosed with your letter were revised plans and you requested that they be reviewed.

Please be advised, as it is stated in the January 22, 2009 letter (which is enclosed herein and highlighted for your reference), that if you decide to revise the proposed project to be considered for an exemption to the Highlands Act, you must resubmit a complete application for a new Highlands Applicability and Water Quality Management Plan Consistency Determination. Therefore, a formal application will be needed for the modified proposal to be considered.
