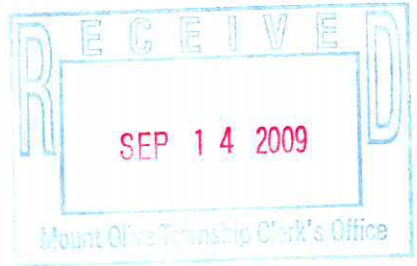

Reference: Notification of Environmental Investigation

Dear Sir/Madam:

Motiva Enterprises, LLC (Motiva) is investigating environmental conditions at 90 Route 206, Flanders (Mount Olive Township), NJ, tax block 9202 and lot 8 (the "property"), in order to determine the presence or absence of petroleum-related constituents potentially resulting from gasoline station operation for which the New Jersey Department of Environmental Protection (NJDEP) has established soil and groundwater quality standards. The investigation has identified the presence of petroleum-related constituents in groundwater and/or soil at the property.

Under "Notification and Public Outreach" rules recently established by the NJDEP (N.J.A.C. 7:26E), this notification is being provided to all owners and tenants within 200 feet of the property boundary to promote awareness that an environmental investigation is being conducted at the property. The NJDEP has assigned Preferred Identification Number 011077 to the environmental investigation. This notification is just for your awareness. No action on your part is needed.

The currently known extent of groundwater and/or soil impact is within the property boundary. The environmental investigation is proceeding in accordance with NJDEP requirements.

A copy of reports submitted to the NJDEP related to the environmental investigation for this site will be made available to Township of Mount Olive upon Township of Mount Olive's request.
