To Whom it May Concern:

In accordance with N.J.A.C. 7:26E-1.4(h)(5), enclosed please find an electronic and hard copy of photographs of the sign that has been posted at the above referenced property (the Property).

Soils at the Property have been impacted by a discharge from former underground storage tanks located at the Property. The contaminants that have been identified in soils at the Property at levels that exceed the NJDEP Site Remediation Standards consist of total petroleum hydrocarbons (TPHC), ethylbenzene and total xylenes. The soil contamination has been delineated, the results of a sensitive receptor evaluation indicate that there are no impacted receptors, and the results of recent ground water sampling demonstrate compliance with the applicable NJDEP Ground Water Quality Criteria.

By copy of this letter, we are notifying the municipal officials that a copy of all environmental reports submitted to the New Jersey Department of Environmental Protection (NJDEP) will be provided to the municipality upon its request.
