**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP
OF MOUNT OLIVE AUTHORIZING A CONTRACT WITH ROBERT PERKOSKI
FOR THE FARMING OF CHARTERS FARM, BLOCK 8300 LOTS 3 AND 4,
UNDER THE "NON-FAIR AND OPEN" CONTRACTS IN ACCORDANCE WITH
THE PAY-TO-PLAY LAW**

WHEREAS, the Charters Farm located on Block 8300 Lots 3 and 4 and owned by the Township of Mount Olive is required to follow the regulations of the New Jersey Farmlands Preservation Act and is in need of the services of a qualified farmer; and

WHEREAS, the Township is seeking limited short term services of a farmer to comply with the Farmland Preservation regulations and of the Morris County Agricultural Board, therefore prompting the need to request quotes; and

WHEREAS, solicitation for quotes were solicited on September 18, 2009 to five local farmers requesting quotes to prepare the soil for planting, plant a winter crop for 2009, and plant and harvest a crop in 2010; and

WHEREAS, the Township plans to auction the property in 2010 with the stipulation that the planted crops may be harvested by the farmer hereby authorized; and

WHEREAS, one quote was received on Tuesday September 29, 2009 as follows:

**2009 - 15 acres at \$150.00 per acre = \$2,250.00
2010 - 15 acres at \$150.00 per acre = \$2,250.00
Total Contract Price = \$4,500.00**

WHEREAS, under the "non-fair and open" provisions of N.J.S.A. 19:44A-20.4 or 20.5 as appropriate the vendor has completed and submitted a Business Entity Disclosure Certification which certifies they have not made any reportable contributions to a political or candidate committee in Mount Olive in the previous one year, and that the contract will prohibit them from making any reportable contributions through the term of the contract; and

NOW THEREFORE BE IT RESOLVED by the Township Council of the Township of Mount Olive that it does hereby authorize the Mayor to execute a contract with Robert Perkoski for \$4,500.00 with the Township of Mount Olive as described herein; and

BE IT FURTHER RESOLVED that the Business Disclosure Entity Certification and the Determination of Value to be placed on file with this resolution.
