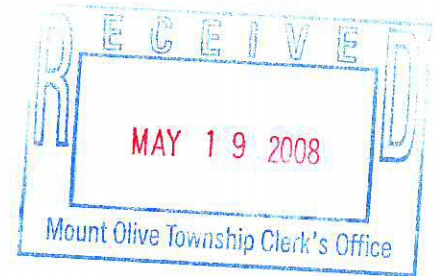

Please take notice that pursuant N.J.S.A. 59:8-4 et seq., a claim is hereby made against the State of New Jersey as follows:

- a) Claimant, Michael Pisano, 6 Winchester Avenue, Hackettstown, New Jersey 07847;
- b) Notice is to be sent to Baker, Pedersen & Robbins, 1 Newark Street, P.O. Box 1278, Hoboken, New Jersey 07030;
- c) Michael Pisano sustained personal injuries on April 14, 2008 in a motor vehicle accident on Interstate 80 East in Roxbury, New Jersey. Claimant was caused to be injured when a highway road reflector manufactured by Stimsonite entered the front windshield of his motor vehicle striking his left hand and the left side of his face and left eye.


