**AN ORDINANCE OF THE TOWNSHIP OF MOUNT OLIVE, COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING CHAPTER 375, VEHICLES AND TRAFFIC, OF THE TOWNSHIP CODE TO MODIFY PARKING AND TRAVEL ON PINETREE LANE TO ENSURE SAFE AND EFFICIENT FLOW OF TRAFFIC**

**WHEREAS**, the U.S. Postal Service (USPS) mailboxes serving residents who live on Pinetree Lane were historically located on a curved portion of Manor House Road, which resulted in access and safety issues for residents who had to traverse sloping, wooded terrain between the homes and mailboxes to retrieve mail and packages; and

**WHEREAS**, after petitioning the USPS for more than a year to move the mailboxes, Pinetree Lane residents ultimately obtained approval and the mailboxes will be moved to the south side of Pinetree Lane; and

**WHEREAS**, the Mount Olive Police Chief has recommended certain changes regarding travel and parking on Pinetree Lane to ensure the safe and efficient flow of traffic; and

**WHEREAS**, the Mayor and Council find it in the best interest of the Township to amend the Township Code to incorporate the Police Chief's recommendations.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Council of the Township of Mount Olive, County of Morris, State of New Jersey, as follows:

**SECTION 1.** Chapter 375, Vehicles and Traffic, Article II, Traffic Regulations, § 375-8, One-way streets, of the Township Code is hereby amended to add the following language:

<b>Name of Street</b>	<b>Direction of Travel</b>	<b>Limits</b>
Pinetree Lane	South	From Chickadee Road to Falcon Drive

**SECTION 2.** Chapter 375, Vehicles and Traffic, Article III, Parking, Standing and Stopping, § 375-21, Parking prohibited at all times, of the Township Code is hereby amended to add the following street:

<b>Name of Street</b>	<b>Side</b>	<b>Location</b>
Pinetree Lane	South	From Chickadee Road to right-of way located on Block 2212 Lot 3
Pinetree Lane Right-of-Way	Both	Entire length of paved right-of-way (Block 2212 Lot 3)

**SECTION 3.** Ordinances, resolutions, regulations or parts of ordinances, resolutions and regulations inconsistent herewith are hereby repealed to the extent of such inconsistencies.

**SECTION 4.** If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by a court of competent jurisdiction, such a decision shall not affect the remaining portions of this Ordinance.

**SECTION 5.** This Ordinance shall take effect twenty (20) days following final passage, approval, and publication as required by law.
