## ORDINANCE OF THE TOWNSHIP OF MOUNT OLIVE, IN THE COUNTY OF MORRIS AND STATE OF NEW JERSEY, AMENDING SECTION 375-22, PARKING PROHIBITED CERTAIN HOURS, AND SECTION 375-27, NO STOPPING OR STANDING CERTAIN HOURS, OF THE TOWNSHIP CODE TO IMPROVE TRAFFIC FLOW DURING SCHOOL HOURS

**WHEREAS**, there currently exists a need to improve traffic flow during school hours at Mountain View Elementary School; and

WHEREAS, the Township Chief of Police has reviewed and approved the traffic study; and

**WHEREAS**, the Mayor and Council of the Township of Mount Olive have determined that it is in the best interest of the Township to make this change.

**BE IT ORDAINED** by the Council of the Township of Mount Olive, in the County of Morris and State of New Jersey, as follows:

**SECTION 1.** Part II, General Legislation, Chapter 375, Vehicles and Traffic, Article III, Parking, Standing and Stopping, § 375-22, Parking prohibited certain hours, of the Code of the Township of Mount Olive is hereby amended to include the following roads and **added** to the existing roads already listed in the code:

Name of Street	Side	Hours/Days	Location
Cloverhill Drive	East	School zone hours	400 feet south from Linwood Road
Linwood Road	Both	School zone hours	Entire length

**SECTION 2.** Part II, General Legislation, Chapter 375, Vehicles and Traffic, Article III, Parking, Standing and Stopping, § 375-27, No stopping or standing certain hours, of the Code of the Township of Mount Olive is hereby amended to include the following road and **replacing** the existing roads already listed in the code:

Name of Street	Side	Hours/Days	Location
Cloverhill Drive	East	School zone hours	400 feet south from Linwood Road
Linwood Road	South	School zone hours	Within the indented area

**SECTION 2.** If any section, subsection, clause, or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by any court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

**SECTION 3.** This Ordinance may be renumbered for purposes of codification.

**SECTION 4.** This Ordinance shall take effect twenty (20) days following final passage, approval, and publication as required by law.
