ORDINANCE AMENDING SECTION 3(j)(ii) AND SECTION
3(o)(i) OF BOND ORDINANCE #7-2022 OF THE
TOWNSHIP OF MOUNT OLIVE, IN THE COUNTY OF
MORRIS, NEW JERSEY, FINALLY ADOPTED MARCH 9,
2022 IN ORDER TO INCLUDE ADDITIONAL PROJECTS.

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF
MOUNT OLIVE, IN THE COUNTY OF MORRIS, NEW JERSEY (not less than two-thirds
of all members thereof affirmatively concurring) AS FOLLOWS:

Section One. Section 3(j)(ii) of Bond Ordinance #7-2022 of the Township of
Mount Olive, in the County of Morris, New Jersey (the "Township"), finally adopted March
9, 2022 ("Bond Ordinance #7-2022"), is hereby amended to include the purchase of an
ATV trailer and upfitting of a trailer and to read as follows:

"(j)(ii) Replacement of in-car digital video equipment, automated license
plate readers, including related equipment and setup, and an automated
external defibrillator and training equipment, the purchase of an ATV trailer
and upfitting of a trailer, including all related costs and expenditures
incidental thereto."

Section Two. Section 3(o)(i) of Bond Ordinance #7-2022 is hereby amended to
include the purchase of two pickup trucks with related equipment and to read as follows:


"(o)(i) Acquisition of a paving box, a street sweeper, a bucket truck, an
asphalt curb machine, a pickup truck with a plow, liftgate and radios, a
single axle dump truck with plow, salter and radio and the purchase of two
pickup trucks with related equipment, including all related costs and
expenditures incidental thereto."

Section Three. The Township hereby certifies that it has adopted a capital budget
or a temporary capital budget, as applicable. The capital or temporary capital budget of
the Township is hereby amended to conform with the provisions of this ordinance to the

extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section Four. This ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.
