

**ORD.#15-2021**

ORDINANCE AMENDING SECTIONS 3(d)(ii), 3(g)(iii), 3(i),  
3(j)(i), 3(j)(iii) and 3(k)(ii) OF BOND ORDINANCE #4-2020,  
AS AMENDED BY ORDINANCE #9-2021, OF THE  
TOWNSHIP OF MOUNT OLIVE, IN THE COUNTY OF  
MORRIS, NEW JERSEY, FINALLY ADOPTED MARCH 3,  
2020 AND MARCH 31, 2020, RESPECTIVELY, IN ORDER  
TO INCLUDE ADDITIONAL PROJECTS FOR SEVERAL  
PURPOSES.

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF  
MOUNT OLIVE, IN THE COUNTY OF MORRIS, NEW JERSEY (not less than two-thirds  
of all members thereof affirmatively concurring) AS FOLLOWS:

Section One. Section 3(d)(ii) of Bond Ordinance #4-2020, as amended by  
Ordinance #9-2021 (together, the "Original Bond Ordinance"), of the Township of Mount  
Olive, in the County of Morris, New Jersey (the "Township"), finally adopted March 3,  
2020, as amended March 31, 2020, is hereby amended to include a heating, ventilation  
and air conditioning unit for the fleet maintenance building and to read as follows:

"(d)(ii) Acquisition of a light tower with generator, a trailer with cattle guard  
and a heating, ventilation and air conditioning unit for the fleet maintenance  
building, including all related costs and expenditures incidental thereto."

Section Two. The description in Section 3(g)(iii) of the Original Bond Ordinance is  
hereby amended to include a heating, ventilation and air conditioning unit for the fleet  
maintenance building and to read as follows:

"(g)(iii) Acquisition of heating, ventilation and air conditioning units for the  
municipal building and the fleet maintenance building, acquisition of snow  
and ice removal equipment, replacement and repair of the fencing at Dan

Jordan Park, replacement of garage doors at Drakes Brook Park and improvements to the Flanders Park multipurpose field and improvements to Turkey Brook Park, including, but not limited to, the turf football field, including all related costs and expenditures incidental thereto and further including all work and materials necessary therefor and incidental thereto."

Section Three. The description in Section 3(i) of the Original Bond Ordinance is hereby amended to include a sanitation rack body, a roller with trailer and a zero-turn mower and to read as follows:

"(i) Acquisition of rear loading packers, automated packers, a sanitation rack body, a roller with trailer and a zero-turn mower, including all related costs and expenditures incidental thereto."

Section Four. The description in Section 3(j)(i) of the Original Bond Ordinance is hereby amended to include a heating, ventilation and air conditioning unit for the fleet maintenance building and to read as follows:

"(j)(i) Acquisition of tires for a loader and a heating, ventilation and air conditioning unit for the fleet maintenance building, including all related costs and expenditures incidental thereto."

Section Five. The description in Section 3(j)(iii) of the Original Bond Ordinance is hereby amended to include a heating, ventilation and air conditioning unit for the fleet maintenance building and to read as follows:

"(j)(iii) The acquisition of a portable air tank, compressor, lift gate and a heating, ventilation and air conditioning unit for the fleet maintenance building, including all related costs and expenditures incidental thereto."


Section Six. The description in Section 3(k)(ii) of the Original Bond Ordinance is hereby amended to include a heating, ventilation and air conditioning unit for the fleet maintenance building and to read as follows:

"(k)(ii) Acquisition of a dump truck with a plow and salter, an asphalt crack sealer and a heating, ventilation and air conditioning unit for the fleet maintenance building, including all related costs and expenditures incidental thereto."

Section Seven. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section Eight. This ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.
