Ordinance #10-2020

BOND ORDINANCE AMENDING IN ITS ENTIRETY SECTIONS 3(k) AND 3(l) OF BOND ORDINANCE #5-2018 OF THE TOWNSHIP OF MOUNT OLIVE, IN THE COUNTY OF MORRIS, NEW JERSEY, FINALLY ADOPTED FEBRUARY 27, 2018, IN ORDER TO AMEND THE DESCRIPTIONS OF THE PROJECTS.

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MOUNT OLIVE, IN THE COUNTY OF MORRIS, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section One. Section 3(k) of Bond Ordinance #5-2018 of the Township of Mount Olive, in the County of Morris, New Jersey (the "Township"), finally adopted February 27, 2018, is hereby amended in its entirety to include improvements to the turf football field at Turkey Brook Park and to read as follows:

"k) Municipal Beach/Turkey Brook Park:

The reopening of the beach, consisting of, but not limited to, the replenishment of sand and improvements to fencing, the lot, the electrical systems and shade structures, and improvements to the turf football field at Turkey Brook Park, including all work and materials necessary therefor and incidental thereto."

Section Two. Section 3(I) of Bond Ordinance #5-2018 of the Township, finally adopted February 27, 2018, is hereby amended in its entirety to include improvements to the turf football field at Turkey Brook Park and to read as follows:

"I) Sports Capital:

The installation of power to the Drakes Brook concession and turf Soccer Field #2 and improvements to the turf football field at Turkey Brook Park, including all work and materials necessary therefor and incidental thereto."

Section Three. The Township hereby certifies that it has adopted a capital

budget or a temporary capital budget, as applicable. The capital or temporary capital

budget of the Township is hereby amended to conform with the provisions of this bond

ordinance to the extent of any inconsistency herewith. To the extent that the purposes

authorized herein are inconsistent with the adopted capital or temporary capital budget,

a revised capital or temporary capital budget has been filed with the Division of Local

Government Services.

Section Four. This bond ordinance shall take effect 20 days after the first

publication thereof after final adoption, as provided by the Local Bond Law.
