**AN ORDINANCE OF THE TOWNSHIP OF MOUNT OLIVE, IN THE
COUNTY OF MORRIS AND STATE OF NEW JERSEY, AMENDING
CHAPTER 375, VEHICLES AND TRAFFIC, OF THE TOWNSHIP CODE
TO REFLECT THE 25 M.P.H. SPEED LIMIT FOR SCHOOL ZONES ON
SANDSHORE ROAD AND WOLFE ROAD**

WHEREAS, pursuant to N.J.S.A. 39:4-98, the speed limit in the Township is “[t]wenty-five miles per hour, when passing through a school zone during recess, when the presence of children is clearly visible from the roadway, or while children are going to or leaving school, during opening or closing hours;” and

WHEREAS, the Township Chief of Police, Township Engineer, and Township Attorney have recommended amending the Township Code to reflect the 25 m.p.h. speed limits for the school zones on portions of Sandshore Road and Wolfe Road.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Mount Olive, in the County of Morris and State of New Jersey, as follows:

SECTION 1. Chapter 375, Vehicles and Traffic, Article II, Traffic Regulations, § 375-7, Speed limits, Paragraph C, of the Township Code is hereby amended to add the following entry:

“Sand Shore Road School Zone	25	From Woodcrest Avenue to Oxford Road, during recess, when the presence of children is clearly visible from the roadway, or while children are going to or leaving school, during opening or closing hours”

SECTION 2. Chapter 375, Vehicles and Traffic, Article II, Traffic Regulations, § 375-7, Speed limits, Paragraph C, of the Township Code is hereby amended to modify the entry for Wolfe Road to read as follows:

“Wolfe Road School Zone	25	From Flanders-Drakestown Road to Kings Arrow Road, during recess, when the presence of children is clearly visible from the roadway, or while children are

going to or leaving school, during opening or closing hours”

SECTION 3. All ordinances of the Township of Mount Olive which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

SECTION 4. If any section, subsection, clause or phrase of this ordinance is for any reason held to be unconstitutional or invalid by any court of competent jurisdiction, such decision shall not affect the remaining portion of this ordinance.

SECTION 5. This ordinance may be renumbered for purposes of codification.

SECTION 6. This Ordinance shall take effect twenty (20) days following final passage, approval, and publication as required by law.
