## Ord.#1-2018

AN ORDINANCE OF THE TOWNSHIP OF MOUNT OLIVE, COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING CHAPTER 285, "PARKS," AND ARTICLE II, "VEHICLES IN TURKEY BROOK PARK," OF THE TOWNSHIP CODE

WHEREAS, §285-4, Prohibited acts, of the Township Code bars certain acts in Township parks, and Article II, Vehicles in Turkey Brook Park, addresses vehicles in only one Township park; and

WHEREAS, the Mayor and Township Council find that it is in the best interest of the Township to amend § 285-4 to prohibit food and drinks from the Pirate's Cove Splashpad and Mount Playmore, except for water contained in a plastic reusable container, and to amend Article II to regulate vehicles in all Township parks.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Council of the Township of Mount Olive, County of Morris, State of New Jersey, as follows:

**SECTION 1.** Section 285-4, Prohibited acts, is hereby amended to establish new subsection "T" to read as follows:

T. No food or drink, except for water contained in a plastic reusable container, shall be allowed in the Pirate's Cove Splashpad and Mount Playmore.

SECTION 2. The title, "Article II, Vehicles in Turkey Brook Park," is hereby amended to read as follows:

Article II: Vehicles in All Township Parks

**SECTION 3.** If any section, subsection, clause, or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by any court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

**SECTION 4.** This Ordinance may be renumbered for purposes of codification.

**SECTION 5.** This Ordinance shall take effect twenty (20) days following final passage, approval, and publication as required by law.
