**ORD.#18-2018**  
**AN ORDINANCE OF THE TOWNSHIP OF MOUNT OLIVE, COUNTY**  
**OF MORRIS, STATE OF NEW JERSEY, TRANSFERRING THE**  
**DIVISION OF BUILDINGS, GROUNDS AND PARKS FROM THE**  
**DEPARTMENT OF ADMINISTRATION TO THE DEPARTMENT OF**  
**PUBLIC WORKS**

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the Township of Mount Olive, County of Morris, State of New Jersey, as follows:

**SECTION 1.** Chapter 5, Administrative Code, Article VII, Department of Administration, § 5-33, Division of Buildings, Grounds and Parks, of the Code of the Township of Mount Olive is hereby repealed in its entirety.

**SECTION 2.** Chapter 5, Administrative Code, Article IX, Department of Public Works, § 5-41, Establishment; Director; Divisions, is hereby amended to establish new paragraph G, to read as follows:

**G.** Division of Buildings, Grounds and Parks.

**SECTION 3.** Chapter 5, Administrative Code, Article IX, Department of Public Works, is hereby amended to establish new § 5-48, Division of Buildings, Grounds and Parks, to read as follows:

**§ 5-48. Division of Buildings, Grounds and Parks.**

The Division of Buildings, Grounds and Parks, which was created on April 9, 2002, by Ordinance No. 13-2002, is hereby transferred to the Department of Public Works, under the supervision of the Supervisor of Buildings, Grounds and Parks. Under the supervision of the Supervisor of Buildings, Grounds and Parks, the Division shall:

- A. Operate and maintain public buildings and grounds owned or leased by the Township.
- B. Provide custodial and janitorial service for all Township buildings.
- C. Administer publicly owned properties.
- D. Plant, care for and trim public parks and greens.
- E. Maintain and repair playfields and playgrounds and recreational areas and facilities, as requested by and pursuant to the instructions of the Division of Recreation.

**SECTION 4.** If any section, subsection, clause, or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by any court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

**SECTION 5.** This Ordinance may be renumbered for purposes of codification.


**SECTION 6.** This Ordinance shall take effect twenty (20) days following final passage, approval, and publication as required by law.
