AN ORDINANCE OF THE TOWNSHIP OF MOUNT OLIVE, COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING CHAPTER 169, DOGS AND OTHER ANIMALS, OF THE TOWNSHIP CODE TO ESTABLISH THE POSITION OF MUNICIPAL HUMANE LAW ENFORCEMENT OFFICER

NOW, THEREFORE, BE IT ORDAINED by the Council of the Township of Mount Olive, in the County of Morris, State of New Jersey, as follows:

SECTION 1. Chapter 169, Dogs and Other Animals, Article I, Dogs; Animal Detention and Redemption, § 169-1, Definitions, is hereby amended to delete the definition for "Animal Control Officer" in its entirety. All other definitions in this Section shall remain the same.

SECTION 2. Chapter 169, Dogs and Other Animals, Article I, Dogs; Animal Detention and Redemption, § 169-2, Animal Control Officer, is hereby amended to read as follows:

The position of Animal Control Officer (ACO) is hereby established. The ACO shall be appointed by the governing body and subject to the control and direction of the Health Officer or his/her designee. The ACO shall be responsible for animal control within the jurisdiction of the Township and shall enforce and abide by the applicable provisions of Title 4, Chapter 19, of the New Jersey Revised Statutes, and any amendments thereof, and the provisions of this Chapter.

SECTION 3. Chapter 169, Dogs and Other Animals, Article I, Dogs; Animal Detention and Redemption, is hereby amended to establish new § 169-3, Municipal Humane Law Enforcement Officer, to read as follows. Current § 169-3 and all subsequent sections in this Chapter shall be renumbered for codification purposes.

§ 169-3. Municipal Humane Law Enforcement Officer

The position of Municipal Humane Law Enforcement Officer (HLEO) is hereby established under the jurisdiction of the Township Police Department. The HLEO shall be appointed by the governing body, upon the recommendation of the Chief of Police. The HLEO shall be responsible for animal welfare within the jurisdiction of the Township, and shall enforce and abide by the provisions of Title 4, Chapter 22 of the New Jersey Revised Statutes, and any amendments thereof, and the provisions of this Chapter. The HLEO shall be authorized to investigate and sign complaints, arrest violators, and otherwise act as an officer for detection, apprehension, and arrest of offenders against the animal welfare and animal cruelty laws of the State and ordinances of the Township.

SECTION 4. Chapter 169, Dogs and Other Animals, Article IV, Cats, current § 169-33 (to be renumbered 169-34), Definitions, is hereby amended to delete the definition for "Animal Control Authority" in its entirety. All other definitions shall remain the same.

SECTION 5. Chapter 169, Dogs and Other Animals, Article V, Feral Cats, current § 169-38 (to be renumbered 169-39), Definitions, is hereby amended to delete the definition for "Animal Control Officer" in its entirety. All other definitions shall remain the same.

SECTION 6. Chapter 5, Administrative Code, Article XII, Department of Health and Welfare, § 5-59, Division of Health, paragraph B, is hereby amended to read as follows:

The Health Officer shall direct the Animal Control Officer to carry out the functions, powers and duties prescribed by statute and such other duties as prescribed by the Director of the Department of Health and Welfare.

SECTION 7. If any section, subsection, clause, or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by any court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

SECTION 8. This Ordinance may be renumbered for purposes of codification.

SECTION 9. This Ordinance shall take effect twenty (20) days following final passage, approval, and publication as required by law.
