ORDINANCE AMENDING SECTION 3(a)(i) OF BOND

ORDINANCE #8-2017 OF THE TOWNSHIP OF MOUNT OLIVE,
IN THE COUNTY OF MORRIS, NEW JERSEY, FINALLY

ADOPTED FEBRUARY 28, 2017, AS AMENDED IN ITS
ENTIRETY BY BOND ORDINANCE #14-2018, FINALLY

ADOPTED APRIL 10, 2018, IN ORDER TO AMEND THE

DESCRIPTION OF A PROJECT.

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MOUNT OLIVE, IN THE COUNTY OF MORRIS, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section One. Section 3(a)(i) of Bond Ordinance #8-2017 of the Township of Mount Olive, in the County of Morris, New Jersey (the "Township"), finally adopted February 28, 2017, as amended in its entirety by Bond Ordinance #14-2018, finally adopted April 10, 2018 ("Bond Ordinance #8-2017, as amended by Bond Ordinance #14-2018"), is hereby amended to include the acquisition of a first responder vehicle as follows:

"(a) Budd Lake Rescue Squad:

(i) The acquisition of an ambulance and a first responder vehicle, including all related costs and expenditures incidental thereto."

Section Two. All other details of Bond Ordinance #8-2017, as amended by Bond Ordinance #14-2018, remain as originally adopted.

Section Three. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section Four. This ordinance shall take effect 20 days after the first publication thereof after
