**AN ORDINANCE OF THE TOWNSHIP OF MOUNT OLIVE, COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING CHAPTER 329, "SMOKING," SECTION 329-1, "SMOKING ON RECREATIONAL FIELDS" OF THE TOWNSHIP CODE TO EXPAND THE TERM "SMOKING" TO INCLUDE E-CIGARETTES AND VAPING**

**WHEREAS**, Section 329-1, Smoking on recreational fields, of the Township Code prohibits any smoking on any recreational field owned by or leased to the Township of Mount Olive; and

**WHEREAS**, the Mayor and Township Council find that it is in the best interest of the Township to expand the term "smoking" to include e-cigarettes and vaping; and

**NOW, THEREFORE, BE IT ORDAINED** by the Township Council of the Township of Mount Olive, County of Morris, State of New Jersey as follow:

**Section 1.** Section 329-1, Smoking on recreational fields, is hereby amended to read as follows:

The Township does hereby specifically prohibit any smoking on any recreational field owned by or leased to the Township of Mount Olive when recreational programs sponsored or under the auspices of the Township of Mount Olive are being conducted on these fields. For purposes of this chapter, "smoking" shall include the smoking of cigarettes, cigars, pipes, e-cigarettes and vaping. For purposes of this chapter, the no-smoking prohibition shall not apply to parking areas surrounding the recreation field.

**Section 2.** If any section, subsection, clause, or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by any court of competent jurisdiction, such decision shall not affect the remaining portions of the Ordinance.

**Section 3.** All ordinances or parts of ordinances of the Township of Mount Olive that are inconsistent herewith are repealed to the extent of such inconsistency.

**Section 4.** This Ordinance may be renumbered for purposes of codification.

**Section 5.** This Ordinance shall take effect twenty (20) days following final passage, approval, and publication as required by law.
