ORDINANCE#27-2015

AN ORDINANCE OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MOUNT OLIVE ESTABLISHING RECREATION FEES FOR VARIOUS TOWNSHIP-SPONSORED RECREATIONAL ACTIVITIES

WHEREAS, the Township has not updated its charges for certain recreational programs in three years to reflect current costs.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Mount Olive, County of Morris, and State of New Jersey, as follows:

SECTION 1. The following fees are hereby established for the following activities:

PROGRAM/ACTIVITY	FEE	Includes programs such as (for all ages):
Administrative Fees	\$5 - \$2000	Refund processing, field /facility permits, Senior Center rentals, etc.
Arts/Crafts/Hobbies	\$0 - 250	Art, Crafts, Cooking, Photography, Sewing, Jewelry, Interior Design, etc.
Budd Lake	\$0 - \$1000	Boat slips, paddle board workshops/lessons, sailing lessons, beach events, parties, Boating Safety, etc.
Camps	\$50 - \$60 0	Day Camps, Specialty camps, Sports camps, Equestrian camp, Fitness camp, Teachers' Convention Camp, Spring Break Camps
Certifications	\$0 - \$450	Red Cross Classes, Bartending License, Point/Auto insurance Reduction Courses, Black Seal Operator, etc.
Donations/Contributions	\$1 – \$1,000,000	Sunshine Scholarship Fund, Arboretum plantings, Sponsor signs, Association Services, Fundraisers, etc
Enrichment	\$0 - \$800	Science, Languages, Computers/Technology, Finance, Business/Careers, Music, Self Improvement, SAT-ACT Prep, Scout Workshops, Pre-School Programs, Nutrition, etc.
Health/Wellness/Fitness	\$0 - \$300	Aerobics, Exercise, Yoga, Zumba, Dance, Karate, Gymnastics, Belly Dancing, Self Defense, Tai Chi, Mommy & Me Movement, Letting Go of Anger, Positive Parent, Special Needs, etc.
Special Events	\$0 - \$100,000	Event admission, parking, vendor spots, ride tickets/wristbands, Event Sponsorship, Tournament related services, event specific services/supplies, etc.
Sports	\$5 - \$800	Badminton, Basketball, Volleyball, Cheerleading, Bowling, Ski/Snowboarding, Golf, Tennis, T-Ball, Sports Camps, Baton Twirling, etc.
Trips	\$5 - \$2000	Family Trips, Sports Games, Tours, Broadway, Concerts, Museums, Exhibits, Cruises, etc.

SECTION 2. This ordinance shall take effect January 4, 2016.
